

Civic Literacy Guidance

In accordance with Board of Governors Regulation 8.006, Civic Literacy Competency Updated January 9, 2025

Background

In 2017, the Florida Legislature amended section 1007.25, Florida Statutes, and introduced a new civic literacy requirement for all students graduating from a Florida public postsecondary institution. Beginning in the fall of 2018, students entering a Florida public postsecondary institution for the first time needed to demonstrate civic literacy by either taking a specific course or passing an assessment. The 2021 Legislature amended section 1007.25, Florida Statutes, and required students to complete both a course and an assessment from the approved list in Regulation 8.006.

During 2024, the Board of Governors revised Regulation 8.006 to better align with the corresponding State Board of Education rule and recognize two new courses meeting the Civic Literacy requirement, AMH 2010 and AMS 2010.

As a result of these changes, four cohorts of students are currently matriculating through Florida public postsecondary institutions subject to varying civic literacy competency requirements. Table 1 outlines the civic literacy requirements based on the specified date of the academic term in which a student initially entered a State University System (SUS) or Florida College System (FCS) institution.

Florida Agricultural and Mechanical University | Florida Atlantic University | Florida Gulf Coast University | Florida International University Florida Polytechnic University | Florida State University | New College of Florida | University of Central Florida University of Florida | University of North Florida | University of South Florida | University of West Florida Additionally, for Cohorts 3 and 4, approved accelerated mechanisms may meet the course and/or assessment requirement, and students who pass the Florida Civic Literacy Examination (FCLE) in high school are exempt from the postsecondary assessment requirement.

Meeting the Civic Literacy Requirement

All undergraduate degree-seeking students who enroll in a Florida public institution in fall 2018 and thereafter must demonstrate civic literacy competency. Table 2 details which options meet the course and assessment requirements for each cohort of students. Some options only satisfy the course or assessment requirement, while others may satisfy both.

Credit received for courses in Board of Governors Regulation 8.006 (AMHX010, AMHX020, and POSX041) via <u>credit-by-exam</u> will count toward the course requirement.

- If the exam used as the basis of awarding credit is in Regulation 8.006 (e.g., AP and CLEP), the student would be considered as having met both the civic literacy competency course and the assessment requirement.
- If the exam used as the basis of awarding credit is not in regulation (e.g., AICE and IB), the student would be considered as having met only the course requirement. These students would need to be assessed using an assessment approved in the regulation.

Beginning with fall term 2024 and thereafter, any undergraduate degree-seeking student, regardless of their cohort, can use any of the approved options for Cohort 4 to satisfy civic literacy competency before graduation.

Guidance for Special Populations and Cases

Students with Disabilities: Pursuant to Section 1007.265, Florida Statutes, and Board of Governors Regulation 6.018, Substitution or Modification of Requirements for Program Admission, Undergraduate Transfer, and for Graduation by Students with Disabilities, universities may substitute a graduation requirement for students where documentation can be provided that the student's failure to meet the requirement is related to the disability and where failure to meet the graduation requirement does not constitute a fundamental alteration in the nature of the program. In the case of civic literacy competency, students with disabilities who are unable to take the required assessment due to the nature of their disability may take a second approved course option to meet the two-part requirement. Florida Statute does not grant institutions or the Board the authority to waive the assessment requirement.

Out-of-State Students: Out-of-state undergraduate students transferring to a State University System institution during the 2024-2025 academic year or thereafter who have never previously enrolled in a Florida public postsecondary institution must meet both the course and assessment requirements outlined for Cohort 4. If the out-of-state transfer student has already taken an equivalent to POS X041, AMH X010, or AMH X020, the institution should review the prior course syllabus to determine if the course included the required competencies outlined in Board of Governors' Regulation 8.006. The same procedures apply to students transferring from private institutions during the 2024-2025 Academic Year or thereafter who have never previously enrolled in a Florida public postsecondary institution.

Associate in Arts and Other Transfer Students: If a student was enrolled in a Florida public postsecondary institution prior to the fall 2018 term, then the student does not have to meet the civic literacy requirement. If a student was enrolled after fall 2018 but has not met the civic literacy competency requirement, then their requirement would be based on the academic term in which the student initially enrolled at the institution awarding the Associate in Arts or Bachelor's Degree.

Dual Enrollment Students: Dual enrollment students who have not already completed the civic literacy competency requirements prior to entering a state university must complete the requirements that correspond with the term the student initially entered the institution as a first-time in college degree-seeking student.

Graduate Students: Graduate students do not have to meet the civic literacy requirement.

Returning Students: Students awarded an associate or baccalaureate degree by a state institution who initially entered prior to fall 2018 are required to meet the civic literacy requirements should they return to seek an additional undergraduate degree if they did not meet the requirements as part of their initial degree.

Students who are required to reapply for admission to their university after a break in enrollment may be placed into a civic literacy cohort based on either their term of initial entry to a state college or university or readmission to a state university at the discretion of the university.

New Naturalized Citizens of the United States of America: A student who took the United States Naturalization/Citizenship Test to become a citizen does not meet the civic literacy requirement solely as a result of taking the test. Without the supplemental questions, the test does not include all of the competencies required by section 1007.25(5)(b)(2), Florida Statutes.

Records Transfer

FASTER has been updated to include indicators for civic literacy on student transcripts for both transfers between postsecondary institutions and transfers between secondary and public postsecondary institutions in the state of Florida. For transfer students, universities should base the civic literacy requirement on the information provided on the student's FASTER record.

Additional Guidance

Accessing and Administering the Florida Civic Literacy Exam (FCLE): Each institution has identified an institution test administrator. This individual is responsible for assigning institutional roles and training exam proctors. If you have recently assumed the role of institution test administrator and need access to the Test Information Distribution Engine, please contact the Board office for assistance. Additional information for institutional test administrators can be found on the Florida Statewide Assessment website.

The FCLE must be administered through Cambium Learning and cannot be imported into a learning management system. The exam must be proctored, and there are tools within the Cambium system that allow the exam to be proctored remotely.

The institutional test administrator can order the following through the Test Information Distribution Engine for students with a documented need.

- Regular print test book and answer book
- Large print test and answer book
- One-item-per-page test and answer materials
- Uncontracted UEB Braille materials
- Contracted UEB Braille materials

Resources are available to orient faculty and students to the nature of the test content and test questions on the FCLE. The content in the Supplemental Guide is not intended to replace associated coursework or other preparation methods required to demonstrate civic literacy, as described in Florida Statute. The sample questions and answers are not intended to demonstrate the length of the actual test.

Student performance on the sample test should not be used as a predictor of performance on the actual test, and neither the sample test nor the supplemental guide should be used to guide classroom instruction.

Accessing and Administering the U.S. Citizenship and Immigration Services Naturalization Test– Civics (U.S. history and government) with supplemental questions: An authorized institutional representative may obtain an approved version of this assessment from the Florida Virtual Campus at no cost to the institution. Institutions must administer all 100 questions of the Naturalization Test – Civics (U.S. History and Government), which includes supplemental questions developed collaboratively by the Board of Governors' staff, the Florida College System staff, and the Lou Frey Institute and incorporated into the test. This is only available to students who enrolled prior to fall 2024.

Multiple Attempts and Maintenance of Records: Institutions will develop and implement their policies related to test administration, including the number of attempts available to students. Additionally, institutions must maintain records of each student's final passing score if the institution administers the exam. The actual scores will not be noted on the student's transcript.

Civic Literacy and Catalog Year: Students are expected to meet the requirements in place at the time they initially entered an FCS or SUS institution, regardless of the catalog year.
